DECLARATION IN RESPECT OF NOTICE OF ALTERATIONS
Fair Work (Registered Organisations) Regulation 126

I, Philip Lovel, as Secretary/Treasurer of the Australian Road Transport Industrial Organization (the organisation) am the officer of the organisation authorised to sign this declaration.

2. The proposed alterations to the rules of the organisation, annexed hereto marked "A", as the Notice of Alterations, were made in accordance with the rules of the organisation.

3. Action taken under the rules to make the alterations was as follows:

(a) in accordance with Federal rules 48 and 33:

- (i) A notice specifying the substance of the proposed alterations to be considered at a Federal Council Meeting to be held on 5 June 2013 was given to each member of the Federal Council (and to each Branch Secretary) on 14 May 2013.
- (ii) The duly quorate Federal Council Meeting held on 5 June 2013 resolved unanimously that

"That Federal Council resolves in favour of the adoption of the rule alterations, as circulated and notified in accordance with the rules."

4. The organisation's website contains a statement that the notice of the proposed ARTIO rule alterations has been lodged with Fair Work Australia.
